



Appendix 2 - FINANCIAL ARRANGEMENTS

(see also Organisation Rules, EOR)

A. GENERALLY, AUTORISATIONS

1. The affiliated federations commit to report to the board of the CEB all international events of billiards which take place in their country, taking care to respect the deadlines for authorisations. For all international tournaments, authorisations have to be requested to the CEB through the respective national federations. The tournaments and organisations will be authorised and take over in the sports calendar as soon as the official attribution is sent.
2. The organizer is obliged to pay the prices in Euro (€) on the place, according to the respective sports rules.
3. Generally, the expenses for travelling and staying are not to be paid by the organiser, unless other arrangements are specified in the respective rules or circumstantial disposals.
4. The attribution of championships and tournaments on the CEB field is in the competence of the board of the CEB. Applications for organizations must reach the CEB by the national federations.
5. These arrangements enter into force in the sports season **2023/2024** and cancel all prior or opposite dispositions on the subject.

B. ORGANIZATION FEES (in Euro):

For all championships, the organiser must take in charge the hotel of the CEB delegate (bed & breakfast – during the competition + 1 night before + 1 night after)

Only for CEB official Invitation Tournaments, the organiser must take in charge the hotel of the CEB delegate for the 2 last playing days (bed & breakfast + 1 night before + 1 night after)

C. INSCRIPTION FEE

For all European individual championship (except youth) an inscription fee of € 150.00 for each sportsman and each competition is to pay (€125.00 for Grand Prix Classics and Artistic, €100.00 for Grand Prix Ladies, € 0.00 for Youth Grand Prix).

This amount increases to € 250.00 for each participating team in the championships for national teams and club teams.

Until the arrangement with UMB exists, the federations have to pay to CEB for the participation of teams and/or individual sportsmen at World championships, a single inscription fee about 250,00 €, it does not matter how many sportsmen/teams they have committed.

D. ANNUAL FEES OF THE FEDERATIONS

All accepted CEB - federations are automatically attached over the CEB at the UMB so far as their financial engagements are in paid.

In the following CEB – contributions, the contributions for UMB are included.

Attending representatives of federations at the UMB congress received of the CEB according (Votes federations UMB) to their free representation of their federation in the UMB congress. Presupposition is therefore, that their due liabilities are paid before the UMB congress.

At the time of new admissions of national federations, the CEB board decides, after seeing the federal facts, of their classification. The CEB board can adjust the whole royalties of the CEB federations to the changes of contributions or licence fees towards the UMB. This is valid also for any change of the voting rights for UMB.

E. PENALTIES

As soon as a tournament or an EC is allocated and even if it is given back to the CEB or does not take place on the territory of this federation, the organizing fees must be paid by this federation.

For the championships without organizing fee an amount of € 1.500,00 must be paid in case of non-organization.

The federations are annually (till the 01. of March) obliged to inform the CEB Secretary general of the CEB about the number of their members and about an up-to-date board list with all required details.

If this information is not provided by 1.March, and if case of recurrence after a reminder, a financial penalty will be applied to the federation concerned (20% of the annual fee of the Federation).

F. ARREARS WITH A PAYMENT

If a federation is in arrears with a payment, a fee of € 50.00 will be charged for the 1st reminder. From the 2nd reminder on that fee increases to 100,00 €.
